

## BYLAW AMENDMENT OF THE HUNTWICK CIVIC ASSOCIATION, INC.

WHEREAS, HUNTWICK CIVIC ASSOCIATION, INC. (the "Association") is charged with administering and enforcing those certain covenants, conditions and restrictions contained in the recorded Declarations for the various sections of the community (collectively referred to as the "Declarations");

**WHEREAS**, the Association's Bylaws are currently filed in the Harris County Real Property Records under File No. U148387 and Film Code No. 529-87-2142;

**WHEREAS**, pursuant to Article XVII of the Association's Bylaws, the Bylaws may be amended upon the approval of at least two-thirds (2/3) of the Association's Members, voting either in person, by proxy or by absentee voting, at a Special or Annual Meeting;

**NOW, THEREFORE, BE IT RESOLVED THAT** that the following Bylaw Amendment is hereby adopted:

1. Article X, Section 2 is hereby amended in its entirety to read as follows:

"Section 2. Budget Oversight. The President is required to call a Special Budgetary Meeting within 60 days of written notification by the Treasurer that (a) the annual Budget expenditures are estimated to exceed the total expense amount of the most recently approved Association annual Budget by more than five percent (5%), or (b) an increase in the Resident Services Fee (aka Special Assessment A in the Revised and Amended Declaration) will be necessary to maintain an adequate reserve of funds. At such meeting, at least two-thirds (2/3) of the Members present in person, by proxy, or voting via absentee ballot, must approve the expenditure of monies which (a) are in excess of more than five percent (5%) of the total expense amount of the most recently approved Association annual Budget, or (b) increase the Resident Services Fee."

Nothing herein is intended to alter, modify or amend the Bylaws except as specifically provided hereinabove.
